POWER SUPPLIES

For use with the RCA Mark VIII Citizens' Band Transceiver

The RCA Type 17705 (12 V) and 17705A (6 V) power supplies are designed for use with the RCA Mark VIII Citizens' Band Transceiver for mobile operation using a DC battery power source.

The instructions given below pertain to an automobile installation, however the equipment can also be mounted in trucks, tractors, or boats in a similar manner.

This sheet contains a parts list, installation instructions, schematic diagram, and voltage conversion instructions for both the 17705 and 17705A power supplies.

Power Supply Installation

 Position the RCA Type No. 17705 Power Supply on the "fire wall" of the automobile within its cable length of the Mark VIII location.

- Mark and drill four 9/64" mounting holes for No. 10 self tapping screws.
- 3. Mount the power supply with four of the No. 10 self tapping screws and No. 10 lock washers.
- 4. Solder one end of the metal braid grounding strap to the solder lug on the power supply.
- 5. Solder the extra solder lug to the other end of the ground strap. Connect this lug to a good auto body ground using a No. 10 self tapping screw and No. 10 washer, drill a 9/64" hole for this if required.
- 6. Connect single wire from fuse holder to battery supply (accessory terminal on ignition switch).
- 7. Place long side of Mark VIII mounting bracket under "dash" (with "L" shaped ends of bracket down) where unit is to be mounted.
- 8. Mark and drill two 9/64" holes to match those in bracket in lower edge of dash. Mount bracket with No. 10 self tapping screws and No. 10 lockwashers.
- Fasten Mark VIII in bracket with two No. 6 self tapping screws and No. 6 lockwashers, use most convenient of the three sets of holes provided in bottom of Mark VIII case.
- 10. Position and form mounting strap to stabilize unit.
- Fasten one end of mounting strap to threaded stud on Mark VIII cabinet. Use a No. 8 lockwasher and 8-32 nut.
- 12. Secure the other end of the strap to the automobile with a No. 10 self tapping screw and No. 10 washer.
- Plug power supply cable into Mark VIII, and connect antenna.

Conversion of RCA Type No. 17705 12 Volt Power Supply for Operation on 6 Volts

CAUTION: Make sure that power to the unit has been disconnected before proceeding with the following steps.

- 1. Unsolder the terminal board end of the wire from pin 2 of the vibrator socket. It is soldered to the terminal with the black lead from T-101. Connect this end of the wire to the terminal with the white lead from T-101 and solder.
- 2. Unsolder the terminal board end of the wire from vibrator socket pin 3. It is soldered to terminal with the yellow lead from T-101. Connect this end of the wire to the terminal with the green lead from T-101 and solder.
- Remove the 12 volt vibrator from socket and replace with 6 V vibrator, RCA Stock No. 220000.
- Remove 8 amp slo-blo fuse from the fuse holder and install 10 amp slo-blo fuse, RCA Stock No. 212156.
- Rewire power cable socket: To remove socket cover, place a small pointed punch against the headless end of the cover retaining pin. A light tap will




Figure 1. Conversion for 6 Volt Operation

move pin head out so that it may be removed with slight twisting counter clockwise pull.

- Remove jumper from pin 1 and pin 7 of power cable socket.
- Solder jumper wire between pin 1 and pin 8, and between pin 3 and pin 7. See illustration. Reassemble cover and socket.




Figure 2. Schematic, 12 Volt Power Supply

Conversion of RCA Type No. 17705A 6 Volt Power Supply for Operation on 12 Volts

CAUTION: Make sure that power to the unit has been disconnected before proceeding with the following steps.

- 1. Unsolder the terminal board end of the wire from pin 2 of the vibrator socket. It is soldered to the same terminal as the white lead from T-101. Connect this end of the wire to the terminal with the black lead from T-101 and solder.
- Unsolder the terminal board end of the wire from vibrator socket pin 3. It is soldered to terminal with the green lead from T-101. Connect this end of the wire to the terminal with the yellow lead from T-101 and solder.
- 3. Remove the 6 volt vibrator from socket, and replace with 12 volt vibrator, RCA Stock No. 220001.
- Remove 10 amp slo-blo fuse from the fuse holder and install the 8 amp slo-blo fuse, RCA Stock No. 214876.
- 5. Rewire power cable socket: To remove socket cover, place a small pointed punch against the headless end of the cover retaining pin. A light tap will




Figure 3. Conversion for 12 Volt Operation

move pin head out so that it may be removed with slight twisting counter clockwise pull.

- 6. Remove jumper wire from pins 1 and 8 and pins 3 and 7 of the power cable socket.
- Solder a jumper wire between pin 1 and pin 7 of power cable socket. See illustration, reassemble cover and socket.




Figure 4. Schematic, 6 Volt Power Supply
